

1. What makes the Federation mission meaningful to you?

- Ensure that transit improvements serve all residents and businesses
- Manage the pressure of new development in order to maintain the uniqueness of the neighborhood

3. What do you see as the greatest opportunities for our community?

The greatest opportunities are to:

- Developing the next generation of leaders in the neighborhood.
- Encouraging positive change for our neighborhood.
- Realizing the Great River Passage plan to advance our neighborhood
- Celebrating the vibrancy of our small-town atmosphere in a big-city area.

4. What strengths would you bring to the Fort Road Federation Board of Directors?

A strength that I bring to the Board is that I know the struggles and successes of the Federation and how the Board can be most effective in dealing with those. It is important for the President to work with the Board and the neighborhood with dignity and respect and I believe that I have been effective in doing so. I try to live a culture of radical hospitality in welcoming everyone to the neighborhood and to the Board to join together in accomplishing our goals.

5. What is your connection to the West 7th neighborhood?

We moved to our home in West 7th in 1974 and have raised our three children here--one of whom still lives in the neighborhood--and my husband's business is located on West 7th. Our family has been involved in the many issues that have been championed by the Federation for more than 40 years.

1. What makes the Federation mission meaningful to you?

The mission is meaningful because I believe the neighborhood we live in benefits greatly from a coordinated effort to support our community needs. These needs have changed over the years, and the Federation has and will continue to respond to these needs as West Seventh changes. The Federation has been an important piece of our community fabric and history, and I am honored to do my small part to bring neighbors together—even when we don't always agree on everything.

2. What do you see as the primary challenges for our community?

One of the biggest challenges is making sure we continue to bring the community together when there are differences of opinion on what is best for the neighborhood. For example, I know many smart "West Seventh Streeters" who don't see rail transit as a benefit to the neighborhood. I also know many smart "West Seventh Streeters" who think rail transit would be one of the best things to happen to the neighborhood in decades. I think both groups have valid points, and the challenge is keeping folks together and focused on the details/impact any possible projects/developments would have on our neighborhood.

3. What do you see as the greatest opportunities for our community?

We have so much momentum going in West Seventh right now, with new restaurants, breweries, and other upcoming exciting projects. We have a great opportunity to continue this positive momentum while making sure we are maintaining our neighborhood feel. Preserving our historic homes and buildings and keeping our independent small business base that make West Seventh unique and special are at the top of my list. But there is no question about it—West Seventh is the place to be.

4. What strengths would you bring to the Fort Road Federation Board of Directors?

I have been on the Federation Board for about four years as an Area Two Coordinator, and I also head up our neighborhood block club. In my work life, I am an Executive Director for a small non-profit organization that serves seniors in Ramsey County. 5. What is your connection to the West 7th neighborhood?

1. What makes the Federation mission meaningful to you?

The Federation's mission centers around the concepts that the organization must advocate for *all* its residents in building a vibrant community, as well as that the organization's goal to empower residents to organize for improvements in our district. This resonates with me because it alludes to increasing the capacity for community-level action. Additionally, I am excited by the work of building a better neighborhood and



strengthening the role of our community in designing our city's future.

2. What do you see as the primary challenges for our community?

Our identity as a community centers around the vitality of West 7th Street, however, the safety of West 7th is of massive concern to all of us and needs to be addressed in the immediate term. If we continue to be defined by a street that is unsafe for pedestrians, bicyclists, and drivers, we miss an opportunity to build a stronger and healthier community. And, as our neighborhood continues to evolve, we have a unique opportunity to develop a vision for ourselves and define our own future by being proactive about zoning and planning, being creative about placemaking and art in our neighborhood, and ensuring that the residents for whom we advocate include the wide diversity of individuals who call our neighborhood "home."

3. What do you see as the greatest opportunities for our community?

I see our community's greatest opportunities as an extension of our challenges; we have an opportunity to create a strategic vision for our community so that we are better positioned to be proactive in protecting and enhancing our neighborhood's assets. We can continue to improve our neighborhood to be one that is connected, resilient, and a place where people want to work, live, play, move, age, and raise families. We have a massive number of people who have lived in the neighborhood for years (if not generations), in addition to newcomers who moved here for the quality of life – bridging these two groups will be essential in ensuring that the direction that our community grows is respectful to these experiences.

2. What do you see as the primary challenges for our community?

3. What do you see as the greatest opportunities for our community?

Andrea McDonald Marboe Area II Coordinators

1. What makes the Federation mission meaningful to you?

I've lived in the West 7th area since 1995 and have seen and appreciated what the Federation has accomplished in the best interests – long term – of the community. The neighborhoods have become more attractive and (I think) stable with FRF and residents' involvement, while retaining historical perspectives of a diverse socioeconomic population. I believe the FRF is integral to making West 7th more welcoming and accessible to



people interested in creating and sustaining a vibrant residential and business community.

2. What do you see as the primary challenges for our community?

West 7th neighborhoods have become very desirable for new homebuyers and renters – especially young adults and families -- and the business community is thriving. We will continue to be challenged by our position as a major transit corridor into downtown and need to remain vigilant about balancing the best interests of the people who live and work here with the city's need for efficient (and attractive) transit options. Affordable housing and senior living options are also increasingly difficult challenges in West 7th neighborhoods.

3. What do you see as the greatest opportunities for our community?

In the coming decade, the FRF – with West 7th residents and businesses – will have important opportunities --

- to influence significant changes/improvements to the landscape/land use of the corridor,
- to advise new and potential business owners and developers regarding development and design, and
- to open wider channels of communication between and among area residents, business owners and the FRF to share issues, concerns and ideas that will shape our community.

We need to make intentional outreach to engage people who have an interest in neighborhood developments, and to cultivate cultural and age and socioeconomic diversity in all of our community-building efforts.

4. What strengths would you bring to the Fort Road Federation Board of Directors?

Through my consulting business, Magpie Solutions, LLC, I bring 25 years of experience to health care, government and nonprofit sector clients to

- develop and implement communications strategies,
- create or improve programs or processes, and
- redesign internal and cross-sectoral systems to achieve the most effective outcomes.

I've served on the boards of the West 7th Community Center and United Family Medicine, and was board chair of UFM during the planning, capital campaign, construction and grand opening of the new Peter J. King Family Health Center at Randolph and West 7th. 
5. What is your connection to the West 7th neighborhood?


Dana DeMaster Area III Coordinator

1. What makes the Federation mission meaningful to you?

It is important "bloom where you are planted," meaning that I have a responsibility to contribute positively in my community. There are many ways to do that, but for me, board leadership with the Fort Road Federation is a clear and direct way to influence and shape my community. I want to live in a community with schools, businesses, and social/recreational opportunities nearby so that the community is supportive to all – whether that is families like mine, an elderly person who wants to age in place, a business looking to expand, or a new resident looking for connections.



The primary challenge for the West End are related to managing change while maintaining the qualities that



make the West End unique. Demographic changes are impacting the city and region, and the West End is not exempt. New immigrants, younger people with different expectations around housing and transportation, and the needs of an aging Baby Boomer population will all be challenges over the coming years. How do we support long-term residents who bring a sense of place and continuity, while incorporating new residents and new ideas? How do we influence and shape development and infrastructure along West 7th that supports the business community, increases safety for all road users, and makes our main street an enjoyable space people want to be in?

3. What do you see as the greatest opportunities for our community?

Our biggest challenges are also our greatest opportunities. While people have many different opinions on Riverview, the project brings great opportunities to improve transportation for all, improve the pedestrian/bicycle environment on and along West 7th Street, and bring new customers for local businesses. With redevelopment of the Schmidt Brewery/Keg and Case, along with more transportation choices to get here, there are great opportunities to draw attention to the area, make it a regional destination, and draw other development along West 7th Street. Changes in city leadership also bring opportunities, such as collaborating with the new Saint Paul Downtown Alliance to make West 7th Street an entertainment and business gateway into downtown.

4. What strengths would you bring to the Fort Road Federation Board of Directors? I bring previous board experience so Lunderstand the duties and responsibilities of a board experience.

I bring previous board experience so I understand the duties and responsibilities of a board member. While living in Hamline-Midway I organized neighborhood activities like two Paint the Pavement events and a block party that drew more than 200 people each year. Professionally, I work in program evaluation and bring more than 15 years' experience in strategic planning, performance measurement, and program development.

5. What is your connection to the West 7th neighborhood?

I have been a resident of the neighborhood since 2015 and a Saint Paul resident for 16 years.

1. What makes the Federation mission meaningful to you?

In order to have a vibrant community where all can live, learn, and grow, there needs to be physical, social, and economic opportunities for all. The Fort Road Federation is a steward of the community to ensure that the neighborhood has these qualities into the future. As a neighbor who loves this community and has one child in a neighborhood school and another in a neighborhood child care center, I am very invested in making sure that our community remains vibrant.



2. What do you see as the primary challenges for our community?

West 7th is in the midst of multiple transitions--whether it be our longtime residents needing to access amenities and services changing to meet their needs, our new residents needing community resources for growing families, or our growing artistic community needing opportunities to interact with the public and showcase their work. In addition, our neighborhood is hot, with new restaurants and breweries, small businesses, and housing coming online on a daily basis. Ensuring that our neighborhood is diverse and inclusive ethnically, economically, and socially; be walkable, approachable, and supportive of all of our resident's needs, is our primary challenge and our greatest need to continuing to have a vibrant community.

3. What do you see as the greatest opportunities for our community?

The greatest opportunity is to be a strategic player within the development of the Riverview Corridor. The community is at a critical juncture and we must acknowledge our history, but not let history limit our potential to grow and evolve our community in a healthy and productive way. Included in this is to be forward thinking to the challenge all communities will face as our population ages and the importance of developing and stewarding the growth of a neighborhood that is relevant to all people across the spectrum of age, economic status and ethnicity.

4. What strengths would you bring to the Fort Road Federation Board of Directors?

I am currently finishing my Masters in Public Affairs at the U of M and have served on multiple volunteer boards focused on volunteer and community engagement. I also have extensive professional experience organizing community projects and managing volunteer-based projects--currently with AARP. I have worked with diverse communities and understand the issues that individuals of all ages and families across the economic spectrum face.

5. What is your connection to the West 7th neighborhood?
